## PLEASE READ THIS STATEMENT

The Motor Cycle Union of Ireland (Ulster Centre) Ltd have been made aware of competitors using on-board camera's without being authorised by Clerk of Course prior to the event nor approved the fitting by Scrutineers.

The rule clearly states - **ON-BOARD CAMERAS.**

***Only competitors authorised by COC will be permitted to film from on-board cameras. Applications must be made in writing to the COC where such approval is granted, the installation of the camera and the associated equipment is further subject to approval of the Chief Scrutineer.***

***A copy of Insurance policy must be forwarded with entry form prior to the closing date for inspection; otherwise, no on-board cameras will be allowed to be used.***

This rule is for everyone's safety at the events

The term "on-board" includes the small inside the helmet cameras which are becoming more available with today's technology. ***(Helmet cameras, any size is not permitted).***

Competitors wishing to carry an on-board camera on their machine must produce personal public liability insurance with minimum cover limit of £10M.

The Motor Cycle Union of Ireland (Ulster Centre) will now serve penalties retrospectively when video evidence is produced or found on any social or electronic platform.

The penalties will include exclusion from the events results at which the recording took place, plus a licence suspension for a minimum of three race events. If this occurs at the last event of the season the penalty will carry over into the new season. These penalties cannot be appealed against.
